#### **Administrative Reports:**

-Mayor Keller had no report. Mrs. Richter stated that the sign in front of the new Marathon station may obstruct the view of traffic on Harrison Ave for those making a turn from Carson Ave. Mr. Braun stated that the sign would likely be raised higher to allow better view of oncoming traffic. She also stated that Family Day will be held on Wednesday, June 7.

-Safety Service Director Tom Braun reports that the Harvest Home Lodge project is being punchlisted. The re-paving of the lodge area is still awaiting comment from the Historic Review Board. Road diet will go out to bid in April for work beginning in June. The work should be compete before the Harvest Home Parade.

-Law Director Rohr had no report.

Public Recognition: Ray Kroner and Emily Donohue addressed council regarding some art installations along the Harrison Avenue corridor in conjunction with the road diet project. The current ordinance regarding signage does not allow for signs to be painted on commercial buildings, but makes no allowance for the painting of artistic murals. Mr. Hardig's Zoning Committee will meet on February 21 at 7PM to discuss amendment to the current ordinance, along with funding (i.e., grant money, private donations) for such an undertaking.

Other Business: Financial Disclosures are due by May 15. Harvest Home Fair Planning meeting is February 9 at 6:30 at the Lodge. Mrs. Richter is encouraging all of Council to join the Cheviot Historic Society. Membership is only \$10 per year. Ms. Hawk announced that Leadership Day at Cheviot School will be held on February 10.
