ORDINANCE NO. 24-23

TO ACCEPT THE BID OF HENDY, INC. FOR CITY OF CHEVIOT EMERGENCY SERVICES LOT IMPROVEMENTS; AND TO DECLARE AN EMERGENCY.

WHEREAS, on October 21, 2024, by Resolution 24-14, this Council authorized the Safety-Service Director to solicit bids for improvements to the City's Emergency Services Lots; and

WHEREAS, the Safety-Service Director solicited bids for the improvements to the lot, as well as an alternate bid request for the improvements to the lot plus improvement to the front driveway of the Fire Department; and

WHEREAS, in response to his advertisement, bids were submitted to the City; and

WHEREAS, the lowest and best bid was the base bid submitted Hendy, Inc., which was \$85,152.00 for the lot improvements and an additional \$16,000.00 for the driveway improvements.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING. THAT:

Section 1. This Council hereby accepts the base bid of \$85,152.00 submitted by Hendy, Inc. for the City Emergency Services Lot Improvements, as well as the additional bid for \$16,000.00 for the Fire Department Driveway improvements. The accepted bid shall be in accordance with the specifications on file in the office of the Safety-Service Director.

<u>Section 2.</u> In the event of unforeseen extra work which might be required, the Safety-Service Director shall not approve any such work which exceeds 10% of the project base cost without first receiving the authorization of this Council.

<u>Section 3.</u> The Safety-Service Director is authorized and directed to enter into the necessary contracts with Hendy, Inc. in order to carry out the work covered by this bid.

<u>Section 4.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to keep the City's property in the safest possible condition.
