RESOLUTION NO. 24-18

TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO SOLICIT BIDS FOR THE CHEVIOT EMERGENCY SERVICES UNDERGROUND FUEL TANK IMPROVEMENTS.

WHEREAS, the Safety-Service Director has determined that the City needs to remove and replace the existing underground fuel storage tanks and all the related piping/pumping infrastructure at Cheviot City Hall; and

WHEREAS, the expense for the repaving project is expected to exceed \$50,000.00; and

WHEREAS, because of the expected expense, the project is subject to the competitive bidding requirements; and

WHEREAS, the Safety-Service Director has determined that this project will not cost more than \$150,000.00, and that the project is eligible for Federal grant funds that must be allocated via purchase order by December 31, 2024; and

WHEREAS, this Council approves the Safety-Service Director soliciting bids and accepting the best and lowest bid, so long as it is \$150,000.00 or less, so as to ensure compliance with the competitive bidding requirements and meet the deadline for the Federal grant.


NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO THAT:

Section 1. The Safety-Service Director is authorized and directed to solicit bids for the removal and replacement of the existing underground fuel storage tanks and all the related piping/pumping infrastructure at Cheviot City Hall according to the specifications on file in his office.


Section 2. Upon receipt of the bids, the Safety-Service Director is authorized to accept for the lowest and best bid, in the Safety-Service Director's discretion, so long as it is \$150,000.00 or less.

Section 3. If the bid is more than \$150,000.00, the Safety-Service Director shall present this Council with a summary of the bids received and his recommendation for the lowest and best bid.

Section 4. This resolution shall take effect immediately.




