**TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO EXECUTE ADDENDUM TO
CONTRACT FOR LANDFILL DISPOSAL SERVICES.**

WHEREAS, the City entered into a Contract for Landfill Disposal Services on December 17, 2019 with Rumpke Sanitary Landfill, Inc., which expires on December 31, 2024; and

WHEREAS, by its terms, the Contract for Landfill Disposal Services authorized the parties to extend the contract for additional option periods by agreement; and

WHEREAS, the City of Cheviot wishes to extend the terms of the Contract for Landfill Disposal for an additional three (3) years by executing an Addendum, which is attached hereto as Exhibit "A" and incorporated herein.

**NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE
OF OHIO THAT:**

Section 1. The Safety-Service Director is hereby authorized to execute the Addendum to Contract for Landfill Disposal Services, which is attached hereto as Exhibit "A" and incorporated herein.

Section 2. It is found and determined that all formal actions of this Council concerning and relating to the adoption of this Resolution were adopted in an open meeting of this Council, and that all deliberations of this Council and any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements, including Section 121.22 of the Ohio Revised Code.

Section 3. This resolution shall take effect immediately.

Exhibit A

ADDENDUM TO CONTRACT FOR LANDFILL DISPOSAL SERVICES

This Addendum to Contract for Landfill Disposal Services ("Addendum"), is made the ____ day of December, 2024, to modify and extend the the Contract for Landfill Disposal Services, originally made on December 17, 2019 ("Original Agreement"), between the City of Cheviot, Ohio ("Cheviot") and Rumpke Sanitary Landfill, Inc. ("Rumpke"). Cheviot and Rumpke are collectively referred to as "Parties."

WHEREAS, the Parties entered into the Agreement for services from January 1, 2020 to December 31, 2024; and

WHEREAS, the Agreement allowed the terms to be extended for additional option periods by agreement of the parties; and

WHEREAS, the parties wish to extend the terms for an additional three (3) years, as set forth herein, and modify the Agreement with this Addendum.

IT IS HEREBY AGREED THAT THE AGREEMENT IS EXTENDED AS FOLLOWS:

Effective January 1, 2025 and continuing through December 31, 2027, Rumpke shall continue to furnish a designated disposal site (Rumpke Sanitary Landfill) for the disposal of all garbage and refuse collected by the City. In exchange for providing a disposal site for garbage and refuse, the City shall pay according to the following schedule:

<u>January 1, 2025 to December 31, 2025:</u>	\$38.00 Per Ton
<u>January 1, 2026 to December 31, 2026:</u>	\$39.50 Per Ton
<u>January 1, 2027 to December 31, 2027:</u>	\$41.00 Per Ton

The term of this Addendum shall be for three (3) years beginning January 1, 2025 and continuing through December 31, 2027. This Contract may be renewed for additional option periods upon mutual agreement of both parties.

All other terms of the Agreement shall remain in full force and effect.
