ORDINANCE NO. 25-OC

TO ACCEPT THE BID OF ADLETA, INC. FOR THE RECONSTRUCTION OF TANGENT DRIVE, GROTTO COURT, SELBY COURT, AND ALEX AVENUE.; AND TO DECLARE AN EMERGENCY.

WHEREAS, on May 28, 2024, by Resolution 24-03, this Council authorized the Safety-Service Director to solicit bids for the Tangent Drive, Grotto Court, Selby Court, and Alex Avenue Reconstruction Project; and

WHEREAS, in response to his advertisement, six such bids were submitted to the City; and

WHEREAS, the lowest and best bid was the base bid submitted by Adleta, Inc.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

<u>Section 1.</u> This Council hereby accepts the base bid of \$654,549.35 submitted by Adleta, Inc., for the Tangent Drive, Grotto Court, Selby Court, and Alex Avenue Reconstruction Project. The accepted bid shall be in accordance with the specifications on file in the office of the Safety-Service Director.

<u>Section 2.</u> In the event of unforeseen extra work which might be required, the Safety-Service Director shall not approve any such work which exceeds 10% of the project base cost without first receiving the authorization of this Council.

<u>Section 3.</u> The Safety-Service Director is authorized and directed to enter into the necessary contracts with Adleta, Inc. in order to carry out the work covered by this bid.

<u>Section 4.</u> This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to keep the City's streets in the safest possible condition.
