•	JEDD VII- Hampton Inn	Thomas Braun	expiring 10/1/2026	(2nd term)
•	JEDD Colerain Liberty	David Voss	expiring 4/13/2025	(1st term)

WHEREAS, this Council has determined that the City of Cheviot should be represented on the Board of Directors for the above-mentioned JEDDs by the Safety Service Director Steve Braun, and for said appointment to be retroactive to the expiration of the most recent term or the retirement of the prior Safety Service Director, if applicable.

## NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, THAT:

<u>Section 1.</u> Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD-I Western Ridge, effective July 1, 2023 (1st term).

<u>Section 2.</u> Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD-II Christ Hospital, effective April 8, 2025 (1st term).

<u>Section 3.</u> Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD-IV Harrison Greene, effective September 1, 2023 (1st term).

<u>Section 4.</u> Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD-VI McAlister's, effective December 21, 2023 (1st term).

<u>Section 5.</u> Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD-VII Hampton Inn, for the remainder of the term of the prior Safety Service Director Thomas Braun, effective February 19, 2024.

<u>Section 6.</u> Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD Colerain Liberty, effective April 13, 2025 (1st term).

<u>Section 7.</u> Upon passage of this resolution, the Clerk of Council shall send copies to the Boards of Trustees for Green Township and Colerain Township.
