RESOLUTION NO. 25-11**

**TO APPOINT SAFETY SERVICE DIRECTOR STEVE BRAUN TO THE BOARD OF DIRECTORS FOR CERTAIN JOINT ECONOMIC DEVELOPMENT DISTRICTS.**

**WHEREAS**, the City of Cheviot has several Joint Economic Development Districts ("JEDD") in partnership with Green Township and Colerain Township; and

**WHEREAS**, this Council previously appointed Councilman David Voss and prior Safety Service Director Thomas Braun to represent the City on various JEDD Boards of Directors; and

**WHEREAS**, the terms of the appointments for the following JEDDs have expired and new representatives must be appointed:

**WHEREAS**, this Council has determined that the City of Cheviot should be represented on the Board of Directors for the above-mentioned JEDDs by the Safety Service Director Steve Braun, and for said appointment to be retroactive to the expiration of the most recent term or the retirement of the prior Safety Service Director, if applicable.

**NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, THAT:**

Section 1. Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD-I Western Ridge, effective July 1, 2023 (1<sup>st</sup> term).

Section 2. Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD-II Christ Hospital, effective April 8, 2025 (1<sup>st</sup> term).

Section 3. Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD-IV Harrison Greene, effective September 1, 2023 (1<sup>st</sup> term).

Section 4. Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD-VI McAlister's, effective December 21, 2023 (1<sup>st</sup> term).

Section 5. Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD-VII Hampton Inn, for the remainder of the term of the prior Safety Service Director Thomas Braun, effective February 19, 2024.

Section 6. Safety Service Director Steve Braun is hereby appointed to be the representative for the City of Cheviot on the Board of Directors for the JEDD Colerain Liberty, effective April 13, 2025 (1<sup>st</sup> term).

Section 7. Upon passage of this resolution, the Clerk of Council shall send copies to the Boards of Trustees for Green Township and Colerain Township.


