RESOLUTION NO. 25-18

**TO AUTHORIZE THE SAFETY-SERVICE DIRECTOR TO ENTER INTO A CONTRACT TO
REPAVE AND REPLACE STORM SEWERS ON A PORTION OF NORTH BEND ROAD.**

WHEREAS, Green Township and Hamilton County are completing a reconstruction project on North Bend Road, including the repaving and installation of storm sewers on the Township side of North Bend Road, which consists of the northbound portion of North Bend Road from the City's corporation line to Westwood Northern Boulevard; and

WHEREAS, Green Township and Hamilton County contracted with Rack & Ballauer to complete the work, pursuant to the competitive bidding requirements of the Ohio Revised Code; and

WHEREAS, it is necessary for the City to repave the City side of North Bend Road and replace the storm sewers on the City side, which consists of the southbound portion of North Bend Road from the corporation line to Westwood Northern Boulevard; and

WHEREAS, the City's repaving and replacement of storm sewers on the City side of North Bend Road, is substantially similar to and within the same general scope as the work competitively bid by Green Township and Hamilton County; and

WHEREAS, the estimated cost for Rack & Ballauer to complete the work on the City side of North Bend is \$72,414.05 for paving and \$12,000.00 for storm sewers, the total of which exceeds the competitive bidding threshold established by Ohio Revised Code Section 735.05; and

WHEREAS, the City exempt from competitive bidding requirements if the City is participating in contracts of other political subdivisions for the acquisition of equipment, materials, supplies, or services when the original contract was awarded through a competitive selection procedure.

NOW, THEREFORE BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO THAT:

Section 1. This Council finds that it is necessary for the City to repave the City side of North Bend Road and replace the storm sewers on the City side, which consists of the southbound portion of North Bend Road from the corporation line to Westwood Northern Boulevard.

Section 2. This Council finds that Green Township and Hamilton County's contract with Rack & Ballauer was awarded pursuant to competitive bidding requirements of the Ohio Revised Code, thereby exempting the City from the requirement for competitive bidding if the City participates in the contract.


Section 3. The Safety-Service Director is authorized and directed to enter into the necessary contracts with Rack & Ballauer Excavating Co. Inc. in order to participate in the agreement with the Township and County for the amount of \$72,414.05 for paving and \$12,000.00 for storm sewers on the southbound portion of North Bend Road from the corporation line to Westwood Northern Boulevard.

Section 4. In the event of unforeseen extra work which might be required, the Safety-Service Director shall not approve any such work which exceeds 10% of the project base cost without first receiving the authorization of this Council.

Section 5. This Resolution shall take effect and be in full force from and after the earliest period allowed by law.
