ORDINANCE NO. 25- 14

TO ACCEPT THE BID OF ADLETA CONSTRUCTION, INC. FOR THE BRIDGETOWN ROAD AND NOLAN AVENUE IMPROVEMENTS; AND TO DECLARE AN EMERGENCY.

WHEREAS, on May 28 2024, by Resolution 24-04, this Council authorized the Safety-Service Director to apply for funds from SORTA and enter into agreements to obtain financial assistance for the improvements to Bridgetown Road and Nolan Avenue; and

WHEREAS, the Safety-Service Director solicited bids for the improvements, and in response to his advertisement, five such bids were submitted to the City; and

WHEREAS, the lowest and best bid was the base bid submitted by Adleta Construction, Inc.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CHEVIOT, STATE OF OHIO, TWO-THIRDS OF ALL MEMBERS THEREOF CONCURRING, THAT:

Section 1. This Council hereby accepts the base bid + alternate 1, for a total bid price of \$420,918.78, submitted by Adleta Construction, Inc., for the Bridgetown Road and Nolan Avenue Improvements. The accepted bid shall be in accordance with the specifications on file in the office of the Safety-Service Director.


Section 2. In the event of unforeseen extra work which might be required, the Safety-Service Director shall not approve any such work which exceeds 10% of the project base cost without first receiving the authorization of this Council.

Section 3. The Safety-Service Director is authorized and directed to enter into the necessary contracts with Adleta Construction, Inc. in order to carry out the work covered by this bid.

Section 4. This ordinance shall be an emergency measure for the health, safety, and welfare of the citizens of Cheviot and shall take effect immediately. The emergency is necessary in order to keep the City's streets in the safest possible condition.


